CI MS #24073 was investigated for Quality of Care/Treatment related to resident not turned/repositioned adequately and other. CI MS # 24009 and CI MS #24044 was investigated for Resident Neglect. During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid and there were no deficiencies cited. However, the facility remains out of compliance due to deficiencies cited on the 1/18/2024 survey. The facility held a license for 230 beds, with a census of 218.	F 000
