CI MS #25236 was<br>investigated related to resident rights. CI MS<br>#25240 was investigated related to staffing,<br>accidents/falls, responsible party not being<br>informed, abuse, and being over sedated. CI MS<br>#25261 was investigated related to rehabilitation<br>services, resident not being turned, facility<br>staffing, cold food not palatable, and call bell not<br>being answered. CI MS #25330 was investigated<br>related to roaches in the facility, no pressure sore<br>precautions, body odor, and staffing. CI MS<br>#25386 was investigated related to incontinent<br>care. CI MS #25407 was investigated for death in<br>the facility.
