F 000	INITIAL COMMENTS The State Agency (SA) conducted four (4) Complaint Investigations (CI MS #25698, CI MS #25708, CI MS #25618 and CI MS #25742), at the facility from 7/15/24 through 7/18/24. CI MS #25698 was investigated regarding incontinent care, not treating resident with dignity, and cleanliness of environment. CI MS #25708 was investigated regarding resident left wet for extended periods, safety related to falls, and resident assessment. CI MS #25618 was investigated for offensive odors, positioning related to tube feeding, and physical environment related to flies. CI MS # 25742 was investigated for nursing care and therapy. During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid and there were no deficiencies cited. However, the facility remains out of compliance due to deficiencies cited on the 6/12/2024 survey. The facility held a license for 230 beds, with a census of 221.	F 000
