F 000	INITIAL COMMENTS Initial Comments: On August 27, 2024 through August 28, 2024 the State Agency (SA) conducted three (3) complaint investigations (CI MS #25916, CI MS #26140, and CI MS #26291), CI MS #25916 for alleged neglect of a resident who issued concerns of pain in her foot and concerns of getting pneumonia; CI MS #26140 for alleged neglect of a resident requesting restorative care from a specific male employee; and CI MS #26291 for alleged resident to resident sexual abuse. The SA determined that the facility was in compliance with the Standards for Participation in Medicare and Medicaid and no deficiencies were cited. The resident census on 08/27/24 was 109 and the facility was licensed for 111 beds.	F 000
