F 000	INITIAL COMMENTS The State Agency (SA) conducted five (5) Complaint Investigations (CI MS #28985, MS#29151, MS #29348, MS #29469, and MS #29493), at the facility from 7/01/25 through 7/02/25. MS #28985 was investigated for falls and resident safety. MS #29151 was investigated regarding food not palatable, inappropriate feeding assistance, and resident safety. MS#29348 was investigated regarding water not offered, resident not groomed adequately, call bells not accessible, infection control, falls, and medications. MS#29469 was a facility reported incident (FRI) regarding abuse and MS #29493 was also investigated related to resident abuse and quality of care. During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid and there were no deficiencies cited. The facility held a license for 58 beds, with a census of 49.	F 000
