CI #16862 was regarding Misappropriation of Property involving misappropriation of narcotics when a medication was not found at count procedures. During the investigations, the SSA determined the facility was in compliance with the requirements of participation in Medicare and Medicaid. The SSA did not substantiate CI #16862 due to lack of evidence. The facility completed a thorough investigation and could not prove who took the medication and contacted the appropriate authorities. No deficiencies were cited. The facility had a census of 62 and is licensed for 90.			F 000
