The facility was found to be in compliance with 42 CFR 483.80 infection control regulations and has implemented the CMS and Centers for Disease Control and Prevention (CDC) recommended practices to prepare for COVID-19. The census at the time of the survey was 98. The State Agency (SA) conducted complaint surveys investigating MS CI #17454 and MS CI #17214 at the facility from 1/19/2021 through 1/20/2021. During the survey, the SA determined that the facility was in compliance with the requirements of participation in Medicare and Medicaid.
