F 000	INITIAL COMMENTS A COVID-19 Focused Infection Control Survey along with a complaint investigation (CI MS #16653, CI MS #17197) was conducted by the State Agency (SA) on 10/27/2020. The facility was found to be in compliance with 42 CFR §483.80 infection control regulations and has implemented the CMS and Centers for Disease Control and Prevention (CDC) recommended practices to prepare for COVID-19. At the time of the survey, the facility had a census of 96 and held a license for 115 beds. CI MS #16653 The result of the investigation was unsubstantiated with no deficiencies cited for Quality of Care related to Facility Staffing and Resident Neglect. CI MS #17197 The result of the investigation was unsubstantiated with no deficiencies cited for Quality of Care related to Facility, Call Bell Not Answered Timely, Resident Not Groomed Adequately, Resident Not Turned, Resident Left Wet for Extended Periods, and Resident Left Soiled for Extended Periods Staffing, Dietary Services, and Resident Neglect. The SA determined the facility was in compliance with Medicare and Medicaid requirements for participation.	F 000
