The facility was found to be in compliance with 42 CFR §483.80 infection control regulations and has implemented the CMS and Centers for Disease Control and Prevention (CDC) recommended practices to prepare for COVID-19. At the time of the survey, the facility had a census of 89 and held a license for 120 beds. CI MS #16781, CI MS #17100 & CI MS #17179 The State Survey Agency (SA) conducted a complaint investigation on 10/8/20. CI MS #16781 was not substantiated for facility staffing. CI MS #17170 was not substantiated for employee to resident abuse. CI MS #17100 was not substantiated for roaches in the facility, staffing, and physical environment. The SA determined the facility was in compliance with Medicare and Medicaid requirements for participation. The facility had a census of 89 and licensed beds for 120.			F 000
