The facility was found to be in compliance with 42 CFR §483.80 infection control regulations and has implemented the CMS and Centers for Disease Control and Prevention (CDC) recommended practices to prepare for COVID-19. At the time of the survey, the facility had a census of 90 and held a license for 120 beds. CI MS #16913 The result of the investigation was unsubstantiated with no deficiencies cited for Resident Verbal Abuse.
