F 000	INITIAL COMMENTS The State Agency (SA) conducted a complaint survey for MS #18061, MS #18639 and MS# 18090 at the facility from 03/30/2022 to 04/01/2022 along with an Employee Vaccination section of the Infection Control survey. During the survey, the SA determined that the facility followed the requirements for participation in Medicare and Medicaid. The SA did not substantiate noncompliance with MS #18061 related to quality of care/treatment services not received and medications not given as ordered, MS #18639 environment roaches and services not received as physician ordered, and MS #18090 short staffing, were not substantiated and there were no deficiencies cited. The facility was licensed for 120 beds and the census was 79 at the time of the survey.	F 000
