F 000	INITIAL COMMENTS The State Agency (SA) conducted a Complaint Investigation (CI), MS #19392, MS #19396, and MS #19408, at the facility from 7/25/22 through 7/26/22. During the survey, the SA did not substantiate MS #19392 for dietary services. MS #19396 was not substantiated for dietary services, abuse, nursing services, medications not given per physician orders, and environment. MS #19408 was not substantiated for sexual abuse or misappropriation of property. However, the facility remains out of compliance with the requirements for participation in Medicare and Medicaid due to deficiencies cited on the 5/26/2022 survey. The facility had a license for 230 beds, with a census of 208.	F 000
