The SA did not substantiate the complaint for Quality of Care/Treatment or Call Bell Not Answered In A Timely Manner By Staff and Accidents/Unwitnessed Fall, and cited no deficiencies; however the facility remains out of compliance with the requirements of participation in Medicare and Medicaid due to deficiencies cited on the complaint survey conducted on December 28, 2022.
