During the survey, the SA determined that the facility was in compliance with the requirements of participation in Medicare and Medicaid Services. There were no deficiencies cited for CI MS# 20891 related to the resident not being closely monitored and allowed to drink shampoo, and CI MS# 20892 related to Quality of Care/Treatment for Care/Service Not Received Per Physician's Order.
