During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid. The SA investigated MS #20692 and MS #20484 for Accidents/Falls and Resident Abuse, MS #21012 for Quality of Care related to Facility Staffing, and MS #20480 for Quality of Care related to resident grooming and cited no deficiencies. At the time of survey the facility was licensed for 102 beds and had a census of 93 residents.	F 000
