MS #19781 was related to facility staffing, residents left wet for extended periods, pressure sores, and hydration. MS # 19896 was related to resident grooming and services not performed per the physician and plan of care. During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid and there were no deficiencies cited.
