The SA investigated MS #20827 for Physical environment related to medical equipment, Resident Rights related to resident not treated with dignity by staff, and Quality of Care/Treatment related to Resident not turned/repositioned, no pressure sore precautions, resident not groomed adequately, call lights not answered in a timely manner, and facility staffing.
