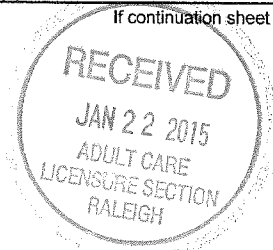

"There is no plural fusion or pneumothorax."<br/>There was no documentation the resident was tested for TB.<br/>-There was no documentation of a 2 Step TB test.</p> <p>Interview with a Manager/Supervisor-in-Charge (SIC) on 12/11/14 at 5:40 p.m. revealed:<br/>-The chest X-ray dated 6/11/14 was in Resident #2's record and was used to admit the resident to the facility.<br/>-The Manager did not know if Resident #2 had tested positive for TB.<br/>-The Manager revealed she contacted Resident #2's prior facility. The representative from the prior facility revealed the resident had the chest X-ray done on 6/11/14, because the resident had a fever.
