K0000 Bldg. 01	INITIAL COMMENTS This survey used the 2012 edition of NFPA 101, Life Safety Code, Chapter 19-Existing Health Care Occupancies and the 2012 edition of NFPA 99, Health Care Facilities Code in compliance with 42 CFR 483.70(a)(b). The facility was located in a two-story building of Type II (111) construction. Resident sleeping rooms were located on both floors of the two-story building. An adjacent one-story building of Type IV (2HH) construction was separated from the two-story building with a fire barrier designed to have a two-hour fire resistance rating. The one-story building housed resident services to include a chapel, gift shop, lounge and cafeteria. The buildings were protected throughout by a wet automatic fire sprinkler system designed to meet the requirements of the 2010 edition of NFPA 13, Standard for the Installation of Sprinkler Systems. An assisted living building was attached to the west side of the two-story building and was separated by an occupancy separation wall having a two-hour fire resistance rating. Observation and records review determined the facility to be in compliance with the minimum requirements of the 2012 Life Safety Code and NFPA 99, Health Care Facilities Code.			K0000
