0000	Initial Comments Inspector Comments: This Statement of Deficiencies was generated as a result of an annual State Licensure survey and complaint investigation at your facility on 01/09/25 in accordance with Nevada Administrative Code (NAC) Chapter 449, Residential Facility for Groups. The facility is licensed for ten Residential Facility for Group beds for elderly and disabled persons, and/or persons with Alzheimer's disease, Category II residents. The census at the time of the survey was five. Five resident files and six employee files were reviewed. The facility received a grade of A. There was one complaint investigated. Unsubstantiated: 1. Complaint #NV00072687 could not be substantiated. No regulatory deficiencies could be identified. The investigation of the Complaint included: Observation of staff to resident treatment, daily rates posted, working televisions, fall precautions, and a tour of the facility. Interviews were conducted with residents, Caregivers, and the Administrator Clinical Record Review of six records, which included the resident of concern. Document Review included incident reports, rate agreement, and daily rates. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigation, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws.
