The facility requested licensure for 10 Residential Facility for Groups beds for elderly and disabled and/or persons with Alzheimer's disease, Category II residents. The census at the time of the survey was zero. One sample resident file and one employee file were reviewed. The facility was provided guidance on having an Infection Control Plan. The facility was provided guidance on the requirements of NRS 449.101 - Discrimination prohibited; development of antidiscrimination policy; posting of nondiscrimination statement and certain other information, NRS 449.102 - Duties of licensed facility to protect privacy of patient or resident, and LCB File No. R016-20 - Cultural competency training; complaint policy; development of gender identity/expression policy; designated person responsible for compliance with these regulations. Failure to comply with NRS 449.101, NRS 449.102 and LCB File No. R016-20 may result in future deficiencies.
