The census at the time of the survey was 8. The sample size was 9 residents and 1 employee. There was one complaint investigated. Unverified: Complaint #NV00068387 could not be verified. No regulatory deficiencies could be identified. The investigation of the complaint included: -Observations and interviews with eight residents who were well groomed with no evidence of injury or distress. -Interviews with the residents, Administrator, the Owner / Operator, and the resident of concern's guardian. -Document review of the facility's abuse policies regarding resident rights, complaint procedure, and admission criteria.
