The sample size was five. There was one complaint investigated. Substantiated without deficiencies: Complaint #NV00012693 was substantiated with no deficient practice. The investigation of the complaint included: Observation of physical environment, resident behaviors, and resident-caregiver interactions. Interviews were conducted with residents, staff, the Owner, and a physician. Record review of five resident records, including the resident of concern. Document review of incident reports, emails, employee files, and a police report.
