Complaint #NV00070634 could not be substantiated. No regulatory deficiencies could be identified. 2. Complaint #NV00070959 could not be substantiated. No regulatory deficiencies could be identified. The investigation of the complaint included: Observation of staff to resident interactions, staff providing snacks and water, residents physical appearance, availability of snacks, meal preparation, residents not isolated and placement of where staff sleep. Interviews were conducted with residents, a Caregiver, and the Owner. Record Review of five resident records, which included the resident of concern and three staff files. Document Review included facility policy and procedures, incident reports, menus, and the Medication Administration record.
