The investigation of Complaints included: Observation of physical appearance for residents, medication administration and a tour of the facility. Interviews were conducted with, Med Techs, the Resident Service Director, and the Administrator. Record Review of five records, which included the resident of concern. Document Review included facility policy and procedures regarding medication services.
