The RFG was found to be in substantial compliance. No regulatory deficiencies were identified. No further action is necessary. Inspector Comments: This Statement of Deficiencies was generated as a result of complaint investigations and a mandatory re-grading survey completed at your facility on 03/23/2026. The facility is licensed for 60 Residential Facility for Group beds for elderly and disabled persons and/or persons with mental illness, with assisted living services, Category II residents. The census at the time of the survey was 43. Ten resident records and seven employee records were reviewed. The facility received a grade of A. There were two complaints investigated. Complaint #12753 could not be substantiated. No regulatory deficiencies could be identified. Complaint #12894 could not be substantiated. No regulatory deficiencies could be identified.
