The facility is licensed for nine Residential Facility for Group beds for elderly and disabled persons and/or persons with mental illness, Category II residents. The census at the time of the survey was eight. Five resident files and three employee files were reviewed. The facility received a grade of A. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigations, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws. Inspector Comments: Based on observation and interview, the facility failed to ensure medications were secured. Findings include: On 09/14/23 at 9:00 AM, the medication closet was unlocked with the padlock in the lock but unlatched. In one unsampled resident's room (Resident #6) was an unsecured medication cup on the bedside table containing approximately eight pills. On 09/07/23 at 9:00 AM, the Caregiver acknowledged the medication closet was unsecured and reported it should have been locked. The Caregiver acknowledged the medication was left on the resident's bedside table and should not have left the medications with the resident unattended.
