0000	Initial Comments Inspector Comments: This Statement of Deficiencies was generated as a result of a mandatory grading resurvey and complaint investigation completed in your facility on 08/19/24, in accordance with Nevada Administrative Code (NAC) Chapter 449, Requirements for Residential Facilities for Groups. The facility is licensed for 108 Residential Facility for Group beds for elderly and disabled persons with Alzheimer's disease which provide assisted living services, Category II residents. The census at the time of the survey was 92. Five resident files and five employee files were reviewed. The facility received a grade of B. There was one complaint investigated. Unsubstantiated 1. Complaint #NV00071801 could not be substantiated. No regulatory deficiencies could be identified. The investigation of the complaint included: Observation of residents receiving care, food provided at lunch, medication administration and a tour of the facility. Interviews were conducted with the resident of concern's family member, residents, a Personal Care Assistant, a Medication Technician, a licensed Pharmacist, the Resident Care Director and the Executive Director. Record Review of five resident records, which included the resident of concern. Document Review included recent menus, facility policy and procedures, and resident pharmacy receipts. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigation, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws. A bottle of glass cleaner, a bottle of air freshener and a bottle of plant fertilizer were left unsecured in the bathroom of Room 403 in the Maple Memory Care Cottage. The resident's door was open and accessible to the main corridor. A resident was observed wandering the hallways and seeking the exits while onsite. On 08/19/24 in the morning, the resident in Room 403 acknowledged the glass cleaner, air freshener and plant fertilizer should be locked securely in a cabinet. The resident verbalized the facility had their toothpaste locked up instead. On 08/19/24 in the morning, the Maintenance Director acknowledged the toxic substances were not secured and should have been. Severity: 2 Scope: 3	0999	The Ant Killer was immediately removed from Apartment 402. The glass cleaner, plant fertilizer and the air freshener were immediately removed and locked up for the resident in 403. All apartments in Memory Care now have a locking cabinet to store chemicals/toxic substances.
