The census at the time of the survey was 93. The sample size was five. The facility received a grade of A. There was one complaint investigated. Substantiated without deficient Practice: 1. Complaint #NV00073291 was substantiated with no deficient practice. The investigation of the complaint included: Observation of physical appearance of residents, lunch, staffing ratios, interactions between staff and caregivers, availability snacks and juice, and a tour of the facility. Interviews were conducted with residents, Caregivers, Medication Technicians, Wellness Director, and the Administrator. Record Review of resident files, including the resident of concern, and staff files. Document Review included policies and procedures, staff schedule, incident reports, menu, invoices for food purchases, and Chat with the Chef minutes. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigation, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws.
