This State Licensure survey was conducted by the Division of Public and Behavioral Health in accordance with NAC 449, Residential Facility for Groups. The facility is licensed for eight Residential Facility for Group beds for elderly and disabled persons, Category II residents. The census at the time of the investigation was eight. The sample size was five. There was one complaint investigated: Complaint #NV00058020 with the allegation the facility lacked supervision of a resident could not be substantiated: The investigation into the allegations included: Observations of residents, the living room area, the dining room, and the kitchen. Interviews were conducted with the Caregiver and the Administrator/Owner. Reviewed five resident records including the resident of concern and the facility policy and procedures on protective supervision. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigation, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws.
