Inspector Comments: This Statement of Deficiencies was generated as a result of an annual survey and complaint investigations completed at your facility on 11/04/2025. The facility is licensed for seven Residential Facility for Group beds for elderly and disabled persons and/or persons with mental illness, and/or persons with intellectual disability, two Category I and five Category II residents. The census at the time of the survey was seven. Seven resident records and three employee records were reviewed. The facility received a grade of A. There were two complaints investigated. Unsubstantiated: 1. Complaint #NV00073933 could not be substantiated. No regulatory deficiencies could be identified. 2. Complaint #NV00074794 could not be substantiated.
