	Initial Comments Inspector Comments: This Statement of Deficiencies was generated as a result of the Annual State Licensure Grading and infection control survey conducted at your facility on 10/19/21, in accordance with Nevada Administrative Code Chapter 449, Residential Facilities for Groups. The facility is licensed for six Residential Facility for Group beds with endorsements for chronic illness and Alzheimer's disease, Category II residents. The census at the time of the survey was six. Six resident records and five employee records were reviewed. The facility received a grade of A. The facility was provided guidance on the requirements of NRS 449.101 - Discrimination prohibited; development of antidiscrimination policy; posting of nondiscrimination statement and certain other information, NRS 449.102 - Duties of licensed facility to protect privacy of patient or resident, and LCB File No. R016-20 - Cultural competency training; complaint policy; development of gender identity/expression policy; designated person responsible for compliance with these regulations. Failure to comply with NRS 449.101, NRS 449.102 and LCB File No. R016-20 may result in future deficiencies.
