Employee #1 verbalized he administered morning medications to residents at 7:30 AM and acknowledged the medication cabinet was unlocked and should be secured when caregivers are not present at the medication cabinet. Employee #1 verbalized the storage cabinet was used for storing empty binders. Employee #1 acknowledged Resident #2's file should be secured and placed the file in the secured filing cabinet designated for resident files.
