	Initial Comments Inspector Comments: This Statement of Deficiencies was generated as the result of a State Licensure COVID-19 Focused Infection Control Survey conducted in your facility on 12/01/20. This State Licensure survey was conducted by the Division of Public and Behavioral Health in accordance with NAC 449, Residential Facility for Groups. The facility was licensed for 10 Residential Facility for Group beds for elderly and disabled persons and/or persons with mental illnesses and/or persons with intellectual disabilities and/or persons with chronic illnesses, with 5 Category I and 5 Category II residents. The census at the time of the survey was seven. There were no COVID-19 positive residents in the facility at the time of the survey. The survey was conducted after the facility reported two residents had tested positive for the virus. The investigation of regulatory compliance for Infection Control and Prevention included: - Visitor entry and facility screening practices; - Education, monitoring, and screening practices of staff; - Emergency staffing plan; - Infection control practices; - Personal protective equipment inventory; - Observation of staff and residents wearing masks and social distancing; and - Interviews with the Administrator. The findings and conclusions of any investigation by the Health Division shall not be construed as prohibiting any criminal or civil investigation, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws. No regulatory deficiencies were identified.			

If deficiencies are cited, an approved plan of correction must be returned within 10 days after receipt of this statement of deficiencies.
