	Initial Comments Inspector Comments: The Statement of Deficiencies was generated as a result of a FOCUSED COVID-19 Inspection conducted in your facility on 11/05/20, in accordance with Nevada Administrative Code (NAC) Chapter 449, Residential Facility for Groups. The facility was licensed for 15 Residential Facility for Group beds which provides assisted living services, Category II residents. The census at the time of the survey was 4. No residents or staff tested positive, nor displayed signs or symptoms for COVID-19. The focused COVID-19 infection control survey included the following: Observations: - Facility checked the temperature of the health facility inspectors prior to entry to the facility. - The health facility inspectors were required to answer COVID-19 screening questions related to symptoms, travel history, and exposure to the virus at other facilities prior to entry to the facility. Inspectors had to wash hands upon entrance. - Visitor log documented temperatures, screening, and dates of visits. - Residents were in their own bedrooms. - Caregivers wore cloth masks and gloves. - Wall mounted hand sanitizer dispensers were located in each hallway and at the main entrance. Facility had eight gallons of sanitizer in storage. - The facility had five electronic temporal thermometer, 20 boxes 100 gloves, 100 surgical masks, 400 N-95 masks, 2 face shields and 50 gowns. Interview: Administrator and a Caregiver were interviewed and verbalized the following: - Screening and temperature checks are completed for staff, visitors, and healthcare workers upon entrance to the facility. Logs are kept of each visitor's screening and temperature. - Temperature checks for residents are conducted daily by caregivers. - No residents or staff have tested positive or showed signs and symptoms of COVID-19. - The residents were separated during meals to promote social distancing. - Activities are limited to adhere to social distancing and keeping residents six feet apart. - Staff sanitizes all high touch areas once each shift with Ecolab disinfectant. - Administrator is in the
