The facility is licensed for 10 Residential Facility for Group beds for elderly and disabled persons and/or persons with chronic illness, mental illness, individuals with intellectual disabilities, Category II residents. The census at the time of the survey was 10. The sample size was 11. The facility received a grade of A. There was one complaint investigated. Substantiated without deficient Practice: 1. Complaint #NV00068052 was substantiated with no deficient practice. The investigation of the complaint included: Observation of grooming and physical appearance of residents, meal observation and a tour of the facility. Interviews were conducted with residents, Caregivers, Ombudsman and the Administrator. Record Review of 11 resident records, which included the resident of concern. Document Review included incident reports and license. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigation, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws.
