Complaint #NV00071933 was substantiated with no deficient practice. The investigation of the complaint included: Observation of the memory care unit, staff providing care to residents, and residents who were bedfast. Interviews were conducted with residents, Caregivers, Memory Care Coordinator, and the Assistant Wellness Director. Record Review of five records, which included the residents of concern. Document review of hospice records and incident reports.
