The RFG was found to be in substantial compliance. No regulatory deficiencies were identified. No further action is necessary. Inspector Comments: This Statement of Deficiencies was generated as a result of a complaint investigation initiated at your facility on 05/06/2026. The facility is licensed for ten Residential Facility for Group beds for elderly and disabled persons and Alzheimer's disease, Category II residents. The census at the time of the survey was eight. Five resident files and three employee files were reviewed. The facility received a grade of A. There was one complaint investigated. Complaint #NV00013432 could not be substantiated. No regulatory deficiencies could be identified. The investigation of the complaint included: Observations of a resident in their room, residents receiving care, staff interaction with residents, and a tour of the facility. Interviews were conducted with residents,
