There was one complaint investigated. Unsubstantiated: 1. Complaint # NV00071255 could not be substantiated. The investigation of the complaint included: Observations of outside agency brochures at the front desk and in the lobby. Interviews were conducted with residents, family members, caregiver staff, ancillary healthcare staff, the Memory Care Director, and the Administrator. Clinical Record Review of six records, which included the resident of concern. Document review included hospice care notes. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigation, actions or lther claims for relief that may be available to any party under applicable federal, state, or local laws.
