	Initial Comments Inspector Comments: This Statement of Deficiencies was generated as a result of an annual State Licensure, complaint investigation and infection control survey conducted at your facility on 05/25/22, in accordance with Nevada Administrative Code (NAC) Chapter 449, Residential Facility for Groups. The facility is licensed for 10 Residential Facility for Group beds for elderly and disabled persons and/or Alzheimer's disease, Category II residents. The census at the time of the survey was nine. Nine resident files and five employee files were reviewed. The facility received a grade of A. One complaint was investigated. Complaint# NV00066335 with one allegation was unsubstantiated. The allegation the facility Administrator told a resident they needed to either be admitted to hospice care or find another group home to live at was unsubstantiated based on interview with the Administrator and resident of concern record review including a Subjective, Objective, Assessment and Plan (SOAP) note dated 05/10/22 documenting the resident's deteriorating medical conditions and recommendation of hospice care. The investigation into the complaint included: Interviews with the facility Administrator and facility Owner/Caregiver. Review of resident of concern's file including physician's history and physical exam notes, home health nurse notes and a SOAP note dated 05/10/22. The facility was provided guidance on the requirements of NRS 449.101 - Discrimination prohibited; development of non-discrimination policy; posting of nondiscrimination statement and certain other information, NRS 449.102 - Duties of licensed facility to protect privacy of patient or resident, and LCB File No. R016-20 - Cultural competency training; complaint policy; development of gender identity/expression policy; designated person responsible for compliance with
