The RFG was found to be in substantial compliance. No regulatory deficiencies were identified. No further action is necessary. Inspector Comments: This Statement of Deficiencies was generated as a result of an annual survey and a complaint investigation completed at your facility on 05/13/2026. The facility is licensed for ten Residential Facility for Groups beds for elderly and disabled persons and/or Alzheimer's disease, Category II residents. The census at the time of the survey was nine. Nine resident files and five employee files was reviewed. The facility received a grade of A. There was one complaint investigated. Complaint #NV00013546 could not be substantiated. No regulatory deficiencies could be identified. The investigation of the complaint included: Observations of residents being supervised by staff, a clean environment with no odors, and a nurse removing discontinued medications from the facility premises.
