The census at the time of the survey was seven. Seven resident files and four employee files were reviewed. The facility received a grade of B. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigations, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws. Inspector Comments: Based on observation, record review, and interview, the facility failed to ensure the Medication Administration Record (MAR) was accurate for 3 of 7 residents (Resident #2, #4, and #5). Findings include: Resident #2 (R2) R2 was admitted on 07/06/23, with diagnosis including senile degeneration. A physician's order dated 07/26/23, and the August MAR documented Ensure, provide each morning with medications. The Ensure was not documented as being given on 08/06/23 according to the August MAR. On 08/07/23 at 10:04 AM, the Caregiver acknowledged the Ensure was not documented accurately on the MAR as administered and should have been. Resident #4 (R4) R4 was admitted on 03/16/23, with a diagnosis including senile degeneration of the brain and kidney failure. A physician's order dated 05/30/23, the medication container/bottle and the August 2023 MAR documented Trazodone 100 milligrams (mg), take one tablet by mouth at bedtime. The Trazodone 100 mg was not documented as being given on 08/05/23. A physician's order dated 05/02/23, the medication container/bottle and the August 2023 MAR documented Haloperidol 1 mg take 1 mg by mouth every morning and evening. The Haloperidol was not		2) Training was done with the team on completing the MAR immediately when medication is given.
