0000	Initial Comments Inspector Comments: This Statement of Deficiencies was generated as a result of an annual state licensure survey and complaint investigation conducted at your facility on 09/04/24, in accordance with Nevada Administrative Code (NAC) Chapter 449, Residential Facility for Groups. The facility is licensed for 10 Residential Facility for Group beds for elderly and disabled persons, with endorsements for mental illness, Category II residents. The census at the time of the survey was eight. Eight resident files and four employee files were reviewed. The facility received a grade of A. There was one complaint investigated. Unsubstantiated: Complaint #NV00071716 could not be substantiated. No regulatory deficiencies could be identified. The investigation of Complaint included: Observation of grooming and physical appearance for residents, and a tour of the facility. Interviews were conducted with residents, caregiver, the Administrator and Owner Record Review of nine records, which included the resident of concern. Document Review of incident reports. The findings and conclusions of any investigation by the Division of Public and Behavioral Health shall not be construed as prohibiting any criminal or civil investigation, actions or other claims for relief that may be available to any party under applicable federal, state, or local laws.
