This is to a group that helps facilitate finding locations for people in need of assistance and care. They put me in touch with a phone number directly associated with the home. At 10:13am I called 918-645-9688. It is a private cell number. The mailbox was full, so I sent a text message identifying myself and asking for a return call. It is currently 1:42pm and I have not received a call back.
