ORDER OF COMPLIANCE

This cause came on to be heard on the 5th day of February, 2019, upon the Petition for Order of Compliance filed by Petitioner, Riverdale Assisted Living Facility, pursuant to a Consent Order issued by the Board on 5th day of October, 2017, which placed Petitioner's license to operate as an assisted living on probation for no less than six (6) months.

Further, the Consent Order required that if Petitioner were to be administering medications to residents, only a licensed nurse or medication technician certified by the Board of Nursing shall dispense medications. Such licensed nurse or certified medication aide will maintain the records of all prescriptions, medication administration records, and progress notes within each resident's file. Petitioner was also required to ensure that all staff undergo training on proper medication administration and disposal. Petitioner was required to provide written proof of such training to the Board.

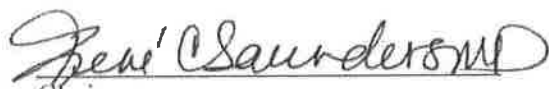
Petitioner also was assessed one (1) civil monetary penalty in the amount of five hundred dollars (\$500.00) for a total assessment of five hundred dollars (\$500.00). Failure to complete the aforementioned requirements or the citation of any further serious

violations affecting the health, safety, and welfare of the facility's residents shall result in Suspension of Admissions pending a prompt hearing by the Board.

Based on the proof provided by the Petitioner, the Board finds that Petitioner has satisfactorily complied with the requirements of the October 2017 Consent Order and probation of Petitioner's license shall be lifted.

Therefore, it is **ORDERED** that the probation of Petitioner's license is hereby lifted and Petitioner's license is returned to an unencumbered status.

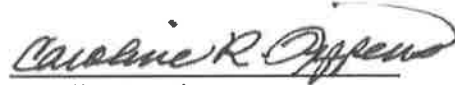
