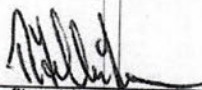

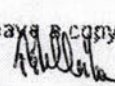
(2) A national fingerprint background check is valid for an indefinite period of time. The adult family home must ensure there is a valid national fingerprint background check for individuals hired after January 7, 2012 as caregivers, entity representatives or resident managers. To be considered valid, the individual must have completed the national fingerprint background check through the background check central unit after January 7, 2012.

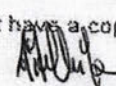
This requirement was not met as evidenced by:

Based on interview and record review, the provider failed to have a national fingerprint background check done on two of three of the caregivers (Caregiver B and Caregiver C). This deficient practice resulted in caregivers, with possible disqualifying crime, to interact and care for all residents in the facility.

Findings included...

During an interview with provider on 8/30/23 1:20 PM, they revealed that Caregiver B (CG B) and Caregiver C (CG C) National fingerprint check background check had not been done.

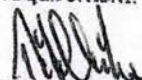
Employee record review at 1:30 PM revealed CG B date of hire was 7/16/23 and didn't have a copy of fingerprint check in their records. *It will be corrected by 9/30/23* 

Employee record review at 1:31 PM revealed CG C date of hire was 9/2/22 and didn't have a copy of fingerprint check in their records. *It will be corrected by 9/30/23*
