(1) The adult family home must have a written plan addressing how they will continue to meet the requirements of this chapter and provide care and services to residents in the event that the provider or entity representative is unable to fulfill their duties in the home and make it available upon request of the department.

This requirement was not met as evidenced by:

Based on record review and interview, the Adult Family Home (AFH) failed to ensure a written succession plan was available for review in the AFH. This failure placed 5 of 5 residents (Residents 1, 2, 3, 4 and 5) at risk of not knowing who would continue to provide care and services in the event the Provider was unable to fulfill their duties.

Findings included...

Record review of the AFH records showed a written succession plan was not available to review.

In an interview, on 03/11/2026 at 2:45 PM, Staff A (Provider) stated that the succession plan would be completed.
