

NOTICE OF CONTINUED AND AMENDED CONDITIONS ON LICENSE

May 26, 2026

Based on the Statement of Deficiencies dated **May 12, 2026**, the Department of Social and Health Services imposes the following continued and amended conditions on the license of **Coyote House, License #752600**, located at **11864 Sunitsch Canyon Road, Leavenworth, Washington**.

The department has determined that the following continued and amended conditions shall be placed on your adult family home license (*amended are italicized, underlined, and bold*):

- **The Adult Family Home (AFH) must hire, at their own expense, an AFH Consultant, not currently or previously affiliated with the AFH, and familiar with AFH policies and regulations by June 9, 2026, to assist in the development and implementation of abuse and neglect policies to ensure residents are free from abuse.**
- **The AFH Consultant shall:**
 - **Review and if necessary, assist in revising or developing AFH resident rights policies, including abuse and neglect policies and mandatory reporting requirements.**
 - **Provide training to all AFH staff regarding:**
 - **Implementation of AFH resident rights policies.**
 - **Implementation of AFH abuse and neglect policies, including:**
 - ❖ **How to recognize abuse and neglect.**
 - ❖ **How to prevent abuse and neglect.**
 - ❖ **What to do when abuse and neglect are suspected or reported in the AFH.**
 - ❖ **How to protect residents when an allegation of abuse or neglect is reported.**
 - ❖ **How to report suspected abuse and neglect as a mandatory reporter.**
 - ❖ **How to communicate suspected abuse and neglect of residents to resident representative and board of directors.**
- **The AFH must provide the AFH Consultant with a copy of the Statement of Deficiencies (SOD) dated May 12, 2026.**
- **The AFH must provide contact information for the AFH Consultant to the Field Manager upon hire.**
- **The AFH Consultant must be available to the department to answer questions.**
- **The AFH Consultant must provide the Field Manager with documentation of staff training no later than June 30, 2026**
- **The licensee must appoint a qualified Entity Representative to delegate and manage the day-to-day operations of the Adult Family Home (AFH) by 5:00 PM on Tuesday, June 30, 2026.**

- **The licensee must provide the name and contact information of the appointed Entity Representative to the Department Field Manager upon appointment.**
- **The AFH provider must post this Notice of Continued and Amended Conditions, with the license, in a visible location in a common use area of the AFH, accessible to residents and visitors.**

These conditions were effective upon **verbal** notice to you on **April 10, 2026**, in a letter dated April 13, 2026. The conditions were continued and amended by **verbal** notice to you on **April 14, 2026**, in a letter dated April 15, 2026. These continued and amended conditions are once again continued and amended upon **verbal** notice to you on **May 26, 2026**, and remain in effect until lifted by formal Department of Social and Health Services notice.
