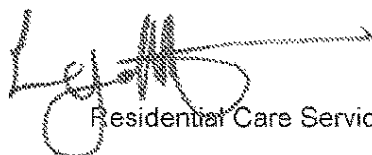

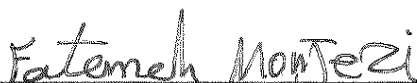

WAC 388-76-10181 Background checks Employment Nondisqualifying information.

(1) If any background check results show that an employee or prospective employee has a criminal conviction or pending charge for a crime that is not disqualifying under chapter 388-113 WAC, then the adult family home must:

(a) Determine whether the person has the character, competence and suitability to work with vulnerable adults in long-term care; and

(b) Document in writing the basis for making the decision, and make it available to the department upon request.

This requirement was not met as evidenced by:

Based on interview and record review, the Adult Family Home (AFH) failed to have written documentation on the Character, Competence and Suitability (CCS) for 1 of 7 staff (Staff F, Caregiver) that had a background check with non-disqualifying convictions. This failure placed all residents at potential risk of harm from a staff whose character suitability for caring vulnerable adults had not been determined.

Findings included...

During an interview on 10/24/2025 at 10:15 AM, Staff A, Entity Representative/Resident Manager, stated that Staff F, Caregiver, worked full time and lived in the home. Staff A further stated that it was Staff F's day off.

Review of Staff F's personnel records showed Staff F was hired on 05/01/2025. Further review of Staff F's files showed a Washington Name and Date of Birth Background Check (BGI) with an expiration date of 02/28/2026 that disclosed Staff F had a non-disqualifying conviction. Additional review of Staff F's records showed no CCS review.

Staff A further stated that they were not aware of the requirement to complete a written CSS. Additionally, Staff A stated they would work on completing a CSS for Staff F's file.
