This requirement was not met as evidenced by:

Based on interview and record review, the adult family home (AFH) failed to ensure its' licensing fee of \$1350.00 was paid when it was due annually in October. This failure placed 4 of 4 residents (Residents 1, 2, 3, 4) at risk of being without a home.

Findings included . . .

A review of department records showed the AFH's invoice balance of \$1350.00 was due on 10/15/2024.

During interview on 12/11/2024 at 1:00 PM, the AFH Provider said they did not know the annual renewal licensing fee was not paid, and acknowledged it had been paid late in the past.

During a follow-up interview on 01/27/2025 at 1:30 PM, the AFH Provider was asked why the annual fee was still not paid as a department records on 01/27/2025, still showed a balance of \$1350.00. The Provider said their business associate assured them that the fee was paid.

This is a repeated deficiency previously cited 12/21/2022.
